As Knights in the State of Louisiana we have accomplished many of our objectives and goals, but there is still much to be completed. Winter is turning into Spring and this will be a great opportunity to accomplish many of our outdoor activities and events.

As I am writing this article, we are traveling throughout the State for the Diocesan Meetings to carry the message of our accomplishments towards as Knights and to promote the efforts to Finish Strong for this Columbian Year. We can not wait until June to implement our plans to accomplish our Goals and Objectives. We must act now to maximize the implementation and effectiveness of our plans.

Councils will qualify for a chance in the Finish Strong Insurance Lottery each month for two Associate to Insurance (A to I) members that month and an additional chance in the Lottery will be earned for every additional A to I member achieved that month. The monthly Finish Strong Membership Lottery and Finish Strong Insurance Lottery will each award \$400 per month to Councils picked in the monthly lotteries. These are great opportunities to earn additional funds for the Council by just implementing the plans to accomplish the Council goals and objectives for the year.

Star Council is an attainable objective for every Council. Now is the time to accomplish the outstanding requirements to satisfy the Membership, Insurance and Program goals to achieve the State Council Award.

The number of Member Suspensions by Councils is at an all time high. I do ask Grand Knights and District Deputies to ensure the Member Suspension process is followed and all efforts are made to speak directly to the Member before implementing the Member Suspension Process. Our priority and focus during this process should be to exhibit charity towards our Brother Knights and ensure that there is no question that the targeted Member wants to discontinue his fraternal benefits and Membership as a Brother Knight in

As we are now approaching the end of the Columbian year there is still time to get in your Youth Expansion Program (YEP) donation. The due date to receive points for the YEP quota is April 5. I will turn in the points to the State Office on April 5. Any money collected after June 30th will be applied to next year quota. Your continued assistance in helping the youths and seminarians of the State of Louisiana is greatly appreciated. By helping the youths and seminarians we are improving their quality of life.

As of this date the Councils have been very generous in their donations. We have a total of 284 Councils in the State of Louisiana. Eighty six councils have already donated \$84,870.25. This leaves 198 councils that have not donated to the program as of yet. Added to these funds are miscellaneous monies that have been collected this year of \$573.00. This now gives us a grand total of \$85,443.25 collected thus far. The program runs from July 1st till June 30th of every Columbian year. The need for us to meet the YEP quota of \$112,100.00 is essential to the existence of our youth programs. We must continue to support YEP because it positively impacts the lives of children and seminarians by empowering them to be productive members of society.

It has been a great privilege to serve you this past Columbian year as YEP Chairman. Thank you for your continued support. I look forward to fellowshipping with each and every one of you at the Knights of Columbus Convention. Thank you again for your donation.

for a moment and then returned to the conversation at hand or the cup of coffee they were enjoying. Some smiled their encouragement; others looked puzzled; still others attempted to communicate with us by means of sign language (like a California howdy). But no one joined our pilgrimage.

It was almost as if there were two groups of people on the streets of Washington, just as there were in the episodes we read in the Gospel. There were those who witnessed to their faith in Jesus and then there were the "city folk" who are confounded by the procession and who ask "Who is this?" Isn't that the question that we all ask, the question even posed by the followers of Jesus? Who is this man hailed by lepers and prostitutes as Messiah? Who is this country hick who rides into the city like a king? We might even ask ourselves, "Who are we who are his devoted followers?"

Just like those folks in Washington, it's little wonder that the inhabitants of Jerusalem are confused in the Gospels. There is nothing about Jesus that would make you want to put down your Starbucks to follow him. He comes not in power but in weakness, not in vengeance but love. Nothing about him conforms to the expectation of a world that has come to believe above all things that might wins.

Who is this? It's the question that comes to a climax at the end of our Lenten journey in order that our story might begin anew and afresh with the hope and promise of a good

Convention Rules

As officers and delegates prepare to depart for this year's State Convention, we urge them to read the following resume of rules that will be applicable for business sessions of the annual meeting. It may be a good idea to bring this article with you.

THE STATE COUNCIL

What makes up the State Council? The State Council consists of the Grand Knight and a past Grand Knight, referred to as delegates, from each subordinate council in good standing in the state; the elected State Officers and the State Chaplain; the immediate Past State Deputy. All of these Brother Knights have both a voice and a vote at the State Council Meeting (Convention).

ATTENDANCE AT STATE CONVENTION

Who attends State Council Meetings (Convention)? All members of State Council and all members of State Family are expected to attend. The State Council has been defined above. The State Family consists of State Officers, the Past State Deputies, the State Chairmen, District Deputies, Diocesan Chaplains, Chapter Presidents, General Insurance Agents, President of Financial Secretaries Association and the State Office Administrator. The State Officers and delegates as defined above have both a voice and vote in the State Council Meeting. Past State Deputies, other than the last living Past State Deputy, and District Deputies, shall be permitted the privilege of membership in State Council, but without the right to vote therein.

WHO MAY SPEAK AT CONVENTION

State Chairmen, who are not otherwise members of said State Council, have the right to speak on questions pertaining to the functions of their particular committees, but without the right to vote therein. The Financial Secretaries of all Councils are expected to attend the State Convention as the meeting of the State Financial Secretaries Association is held during the Convention. The Financial Secretaries have neither voice nor vote in the State Council Meeting. Any Third Degree member is entitled to attend the State Convention as a visitor, but has neither voice nor vote in State Council Meetings. The State Council, can, on request, however, grant the privileges of the floor to a Third Degree member of the Order.

SEATING ARRANGEMENTS

In order that business of the State Council may be efficiently conducted, these rules are to be followed. All delegates and State Family sit in designated sections of meeting hall. The State Family sits in one section and the delegates sit in District groups with their respective District Deputies. All visitors sit in rear of these groups.

ELECTIONS & ROLL CALL

The State Council elects the State Officers and delegates to the Supreme Council (Convention) annually. To expedite this election, the reading of a permanent roll of the State Council and the election are combined in one operation whenever possible.

ELECTION OF OFFICERS & DELEGATES

State Council Officers are, in their order of precedence: The State Deputy, State Secretary, State Treasurer, State Advocate, and State Warden. The Immediate Past State Deputy is ex-officio officer and these men select the State Chaplain. Our Jurisdiction is large enough in membership to be entitled to maximum representation at the Supreme Council Meetings - five (5) insurance delegates and five (5) associate delegates.

ELECTION OF ALTERNATES AS WELL

Our State Council Meetings will elect four (4) insurance and four (4) associate delegates. The State Deputy is ex-officio an insurance delegate and the Immediate Past State Deputy is ex-officio an associate delegate. The State Council also elects five (5) alternates for the insurance delegates and five (5) alternates for the associate delegates. In electing delegates and alternates no majority of the votes cast is necessary. They are elected according to their plurality of votes. Section 4, subdivision 7 (c) of the Charter, Constitution and the Laws of the Order provides that "Vacancies created by the inability of representatives to attend the Supreme Council Meeting shall be filled by the alternate in the order of the precedence, according to the vote electing them, provided that only insurance alternates shall fill vacancies for insurance representatives." In case of a tie vote, the State Deputy shall designate which one shall serve. If the alternate above provided for is not present, the next in order who is present may fill the vacancy. Names on the ballot are printed in alphabetical order.

MUST SUBMIT WRITTEN INFO ON NOMINEE

When making a nomination for a State Office or Supreme Council delegate or alternate, the nominator must submit A WRITTEN NOMINATION on the nominee listing his full name (no nicknames), KC membership number, mailing address with zip code, and KC Insurance Certificate number is being nominated for State Deputy or Insurance Delegate or Insurance Alternate. This written nomination must be submitted to State Secretary or his designate at the time the nomination is made on the floor.

Here's the interesting thing that would happen in our Washington procession. We would journey down K Street to 25th Street, and there we would split up. Catholics and Episcopalians would each take up residence in their own church, walking through the crowds, forced to reflect on one simple question in their own way. When you process back to your busy life after reading this article, focus on that one singular question – "Who is this Jesus we come to worship?"

Council 17205 Louisiana's Newest Council

Several months of effort from the district and state levels of the KoC in Louisiana has finally come into fruition with the establishment of the Fr. Joseph Lafleur Council #17205 over at St. Joseph Seminary (Covington, LA) this month. Currently, we have 35 brother knights in our council and it's growing daily through the grace of God. This has only been possible because of the efforts of all the KoC officers from around the state, support from the Rector of St. Joseph Seminary, the support of Archbishop Aymond, and from my brother seminarians here who responded enthusiastically by joining this council. This is historic as the Fr. Lafleur Council is the very first council named after this heroic priest and the first seminary council in the state of Louisiana. We were inspired to name our newly established council after Fr. Lafleur as he is an alumni from our seminary, a native Louisianian, and he embodied the principles of charity, unity, fraternity, and patriotism throughout his service as an Army Air Corps Chaplain.

Fr. Lafleur received the Distinguished Service Cross twice for his actions on Clark Field (December 8th, 1941) in the Philippines and posthumously for the sacrifice of his life as a prisoner of war onboard a sinking Japanese ship to save the lives of his fellow brothers. Our goals in this council are to live out the principles of the Knights of Columbus and grow as brother knights in conforming ourselves to Christ as we continue our priestly formation. We are all young, devout, and passionate knights and this witness will help in the recruitment of young men to join other councils as they see our example. Furthermore, we will assist in youth recruitment when we participate in various KoC events around the state and when we go back to our home dioceses at the end of the academic year. Keep our council in your prayers as we set the foundation for it and follow our call to the priesthood.

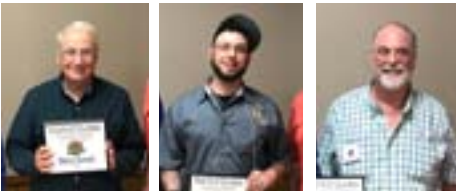
