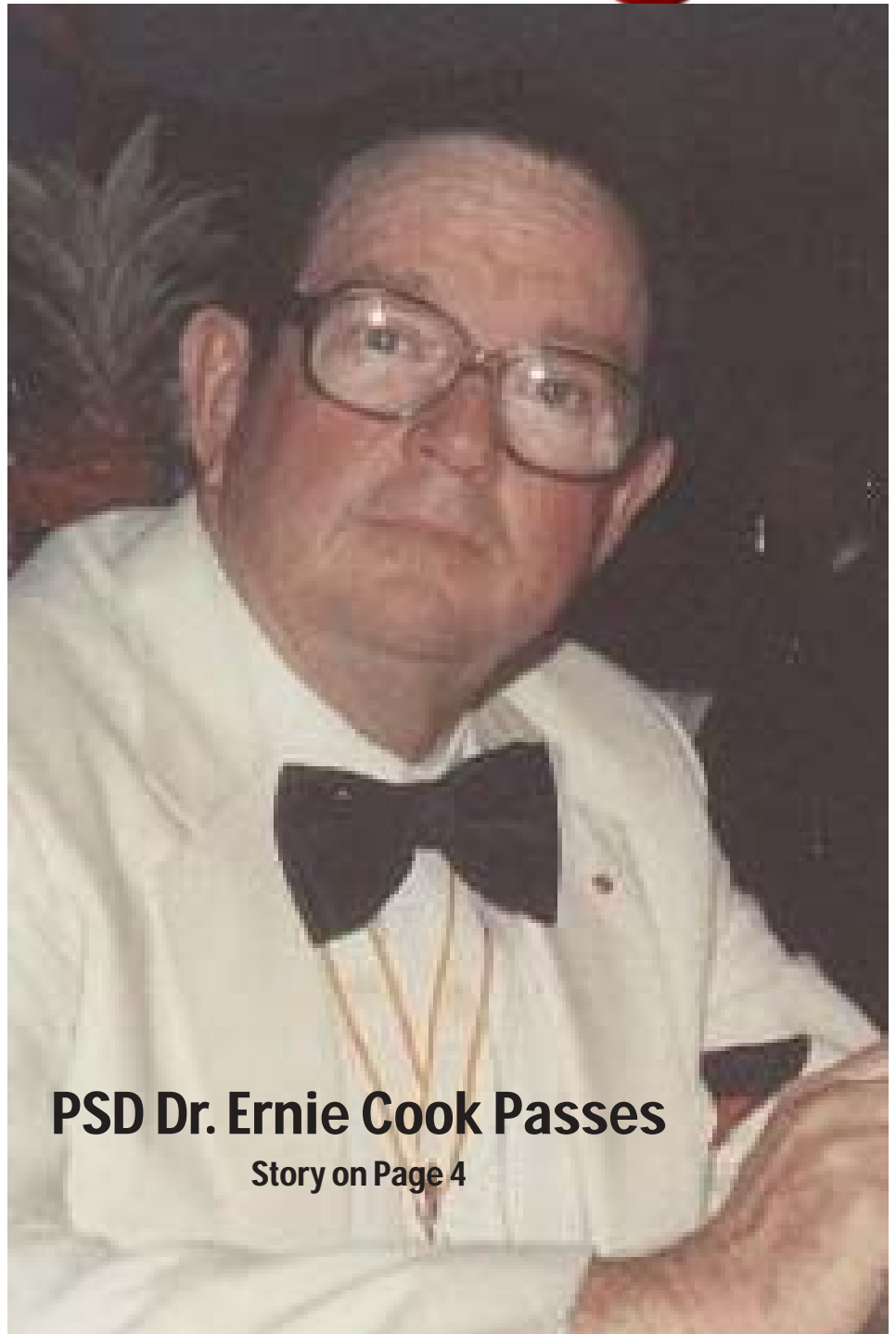

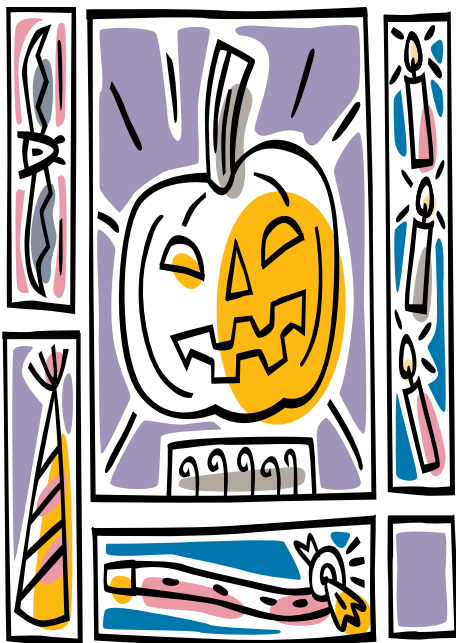

Funeral services were held on Friday, September 26, 2008 at a 11:00 AM Mass of Christian Burial in Our Lady of Fatima Catholic Church in Lafayette for Ernest Joseph Cook, Jr., D.D.S., 77, who died on Saturday, September 20, 2008 at Our Lady of Lourdes Regional Medical Center, Lafayette.

Reverend Keith Landry, Celebrant and Associate Pastor of Sacred Heart of Jesus Catholic Church in Broussard, along with Reverend Blaine Clement, Concelebrant and Associate Pastor of Our Lady of Wisdom Catholic Church in Lafayette conducted the Funeral Mass. Lectors were Michele Martinez, Theresa Domingue, Patrick Huval and Cathy L. Wetzel. Rachel Gaspard, soloist, accompanied by Andre' Courville, organist, sang "Here I Am Lord", "Be Not Afraid", "Spirit Song" and "Sing A New Song" for the services.

Interment took place on Saturday, September 27, 2008 at 12:00 PM in Greenwood Cemetery in New Orleans, LA. Saturday visitation was held at Greenwood Funeral Home, 5200 Canal Blvd., New Orleans, LA from 11:00 AM until time of graveside services. Reverend Gerard LaPorte, C.S.S.R. (Cousin of the deceased) conducted the graveside services.

Dr. Cook is survived by his beloved wife of 48 years, Patricia Smith Cook, M.D. of Maurice, LA and New Orleans, LA; first cousins, Shirley Lutz of Mandeville, LA and Catherine Sadler Carpenter of Alexandria, VA; sisters-in-law and brothers-in-law, W.M. J. Smith, Jr. and Thoy of Denver, CO, Maureen Smith Lockhart of Metairie, Judith Smith McDonald and Patrick of Metairie, Theresa Smith Barrios and Cyril of Austin, TX, T. Michael Smith and Joan of Baton Rouge and Denise Smith Domingue and Louis of Lafayette; his nieces and nephews; and many grand nieces, grand nephews and cousins.

He was preceded in death by his parents, Ernest Joseph Cook, Sr. and Claire Sadler Cook of New Orleans.



A native of New Orleans, LA and a lifetime resident of New Orleans, Dr. Cook was a parishioner of St. Maria Goretti Parish for 36 years until Katrina. His home in New Orleans East, Spring Lake, was so severely damaged that he and his wife took residence in Maurice near relatives. He later became a patient in Evangeline Oaks Guest Home.

He was a graduate of Jesuit High School, attended LSU undergraduate school, and graduated from Loyola University of the South School of Dentistry in 1955. He served in the United States Air Force

as Captain, with a tour of duty in the Northeast Air Command in Greenland. He entered full time private practice of Family Dentistry in 1957 in New Orleans and Metairie, until he retired from Dentistry in 1995.



He was an avid fisherman, duck hunter and trainer/handler of his yellow labrador retrievers, some of whom attained AKC and UKC National titles. He was an active member and held offices in the Pontchartrain Hunting Retriever Club for many years until his illness. He served as President of the Spring Lake Homeowners Association. In the early 1980's he indulged his wife's passion for figure skating and the Figure Skating Club of New Orleans by becoming a co-owner of Ice Sports Pavilion in Jefferson Parish, and was active in the building, management and maintenance of the facility, even learning to operate the Zamboni machine to resurface the ice. For many years he served on the Boards of the New Orleans and Louisiana Associations for Retarded Citi-



zens devoted to their goals. In 1998 he received the Lifetime Achievement Award from the ARC of Greater New Orleans.

His greatest devotion was to his activities in the Knights of Columbus. His father had been a member of N.O Council 714, and his uncle of Council 1905. Dr. Cook joined Cardinal Gibbons Council 2918 in 1957, and served as Recorder, Chancellor, and Grand Knight. He functioned as State and Supreme Convention Chairman, Co-Chairman of YEP, General Program Chairman, State Council Activity Chairman, District Deputy, State Treasurer and State Secretary. In 1982-1984, he was elected as the 38th State Deputy for the Louisiana Jurisdiction, during which time record accomplishments were achieved. Following this, he became a director of the Knights of Columbus Supreme Council Board of Directors, serving the maximum 9 years. This gave him the opportunity to have several private audiences with the Pope, and also with Mother Theresa. An especially "important moment for me as a Catholic and a Knight was receiving Holy Communion from Pope John Paul II at the Papal Mass held in New Orleans in September, 1987"

He was a member of Darro Caravan. He served as Vice-Supreme Master of Bienville Province of the

Fourth Degree of the K of C and became a Knight of St. Gregory the Great in 1989. He was a Knight Commander of the Equestrian Order of the Holy Sepulchre, and Commander in the Order of the Fleur-de-



Lis with life membership. Dr. Cook was a loving husband, cousin, uncle and friend to all. His love and wit will be dearly missed by all who knew and loved him.

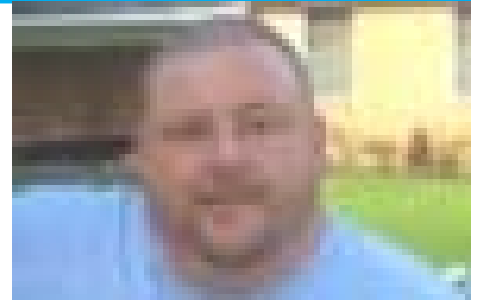

### **Providing Youth Ministry Through Scouting**

In 1913, Knights of Columbus Council No. 1337 was chartered to operate Boy Scout Troop 1 in Monroe, Louisiana and for more than 90 years, the Knights of Columbus has worked with the Boy Scouts of America to serve youth. In 2006, the Knights of Columbus and the National Catholic Committee on Scouting teamed up to start new Scouting units. As you may or may not know, BSA sent out letters in 2005 asking all units chartered by government agencies (public schools, police and fire departments and military posts) to find alternate charter partners so money will not be used in lawsuits that could be used for the Scouting programs. This was the genesis of this program at the national level.

While the main focus of the national initiative is unit retention and growth, discussions between the State Deputy and myself led us to determine that the state program should have five areas of concentration:

1. Retention of Cub Scout, Boy Scout and Venturing units that are in danger of folding due to the loss of their chartering partner;
2. The creation of new Cub Scout, Boy Scout and Venturing units to bring the Scouting program to underserved areas;
3. The promotion and sponsorship of the Catholic Religious Emblems program;
4. The promotion of increased volunteerism in the Scouting program by our Brother Knights, at the unit, district and/or diocesan levels;
5. Recognition of Brother Knights who have given years of service to the Boy Scouts of America through a new state award, the Francis J. Parater Award.

Each Grand Knight received a trifold brochure in their KCLS packet with information on the history of the KCs and Scouting, the Catholic religious emblems, how to start a new unit, statewide Scouting contacts and contacts within each diocese. While our goal is to have a KC Diocesan Scouting Coordinator in each diocese, we still have a few positions to fill. Also included in the brochure is a list of chairmen for each of the diocesan Scouting committees.

Also enclosed in the packet was an application for the Francis J. Parater Award. Frank Parater was an Eagle Scout, a Seminarian and a long time associate of the Knights who died at the age of 23 and is on track to become the first American Scout to be named a saint. Please read over this information and take

the time to consider if you have any worthy Brothers who would be eligible for this award.

Both of these documents are available on the state website in PDF format. If you are unable to download them, please contact me and I will send them to you.

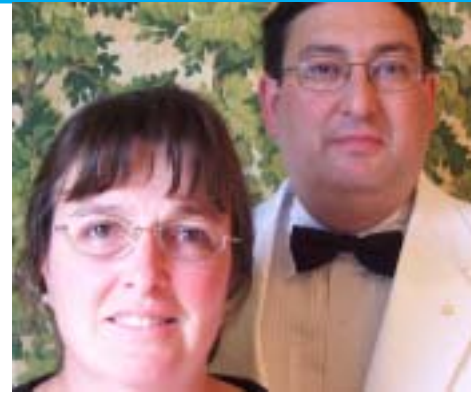
If your council owes money for candy or aprons don't worry, Bro. Robert Boudreaux will deduct that cost from your fund drive check you mail in.

These facilities are truly “the front line of defense” when it comes to preventing abortions in our State. Each facility provides counseling, ultrasound imaging and other critical services to women, who more than often, seriously consider an abortion. The centers handle these ladies who are more than often coerced into visiting an abortion clinic by a boyfriend, a husband, or her parents with respect & compassion. They do not use trickery or coercion themselves; instead they provide each woman with another alternative, life for her growing child. With the right assets provided to them, these ladies chose life about 90% of the time.

We hope that each Council in our State, each Assembly, & each Auxillary Chapter will make an effort to visit their nearest pregnancy resource center and help them by sponsoring a Pro-Life Baby Bottle Campaign in their church parish. The process is very simple, takes just a few minutes of each volunteer’s time, costs the sponsoring group nothing, and each campaign generates thousands of dollars for the center they choose to assist. Please feel free to contact us or your nearest center if you need more information.

With the national elections just around the corner, we would like your help over the next two months in promoting 2008 as a pivotal elec-

tion year for our Country, especially when it comes to Pro-Life issues. The leaders we elect this year will have a significant influence over whether or not Roe v Wade is overturned. Our incoming President will appoint between two and four Supreme Court Justices. The U.S. Senate must approve these appointments before they can sit on the bench. With the right choices, we can overturn Roe v Wade.

How can you help? First, get copies & distribute the publication called “Voter’s Guide for Serious Catholics” which is available from the Catholic Answers website as a booklet or from other sources as a two page front & back handout. Brother Knights, family-friends or relatives to remind them to vote. You can also send out e-mail reminders. So many people simply forget to vote. You may also remind them now to check and make sure that they are registered to vote. Unfortunately, each election, people show up at their voting precinct, only to find out that they are no longer on the rolls. They go home disappointed without casting their vote.

As Knights of Columbus we must step forward and take a proactive role in promoting life in our State. We cannot sit back and let someone else do it for us. Supporting your local pregnancy resource centers and getting others involved in the upcoming election should be a priority for all of our KC groups.
