



The State Budget for YEP funding for the 2012-2013 Columbian Year



Past State Deputy William Guste Moves to Eternal Reward

William Joseph "Billy" Guste, Jr. was born in New Orleans, LA on May 26, 1922. He was the son of William J. Guste, a prominent litigation attorney, and the former Marie Louise Alciatore. Mr. Guste graduated from Jesuit High School in 1938. In 1943, he received a Bachelor of Arts Degree and in 1944. a Juris Doctor Degree from Loyola University. During his attendance at Loyola University, Mr. Guste had served in the U.S. Army Reserve. In 1944, he graduated from Loyola University Law School and on the same day, he was sworn in with the Louisiana State Bar Association and left for active duty in the United States Army. He remained on active duty for 3 1/2 years; serving 2 years overseas primarily in France. In 1945, he was honorably discharged from the Army. He returned to New Orleans after World War II and married Dorothy Schutten "Butsie" Guste, the daughter of Mr. and Mrs. Bernard Schutten. Mr. and Mrs. Guste had ten children-4 boys and 6 girls—during the coming years. They were married for 66 years. From 1945 to 1972, Mr. Guste was engaged in the private practice of law in the firm of Guste, Barnett & Little. In 1968, he was elected to the State Senate where he served until 1972. Mr. Guste worked tirelessly for the poor, oppressed and marginalized through his practice of law. He was recognized as a civil rights activist during the 1960's, and an advocate for the environment. Mr. Guste served as the State Deputy for the Knights of Columbus from 1964-1966. He was a Knight of Malta, the Order of Saint Lazarus and a member of the Order of the Fleur de Lis. Mr. Guste was a member of the Pickwick Club, other social clubs and several

Carnival Balls. For 20 years, from 1972 to 1992, Mr. Guste served as Attorney General of Louisiana. He was elected to 5 consecutive 4-year terms. As Attorney General, he sponsored and secured passage of Louisiana's Consumer Protection Law and its Environmental Protection Law coordinating the work of some thirty (30) agencies involved in environmental work and the revision of the State's criminal law with respect to drugs. In addition, he helped to organize and assist more than 150 citizens' organizations so that they could gain access to government through its bureaucratic maze. Guste argued successfully the Tideland's case in the Supreme Court, and received a settlement of 136 million dollars for the state. A devout Roman Catholic, Mr. Guste was a strong advocate for the rights of the unborn. In 1982, Mr. Guste served as President of the National Association of Attorneys General which consists of the Attorneys General of 50 states and 4 U.S. Territories and received its Wyman Award which is presented to

the Attorney General who has done the most to meet the goals of the Association. In 1983, Mr. Guste was named by President Ronald Reagan as a member of the President's Commission on Organized Crime and served in that capacity until 1986 when the Commission issued its final report to the President. On that Commission, he was appointed Chairman of the Committee on Drug Interdiction and Demand Reduction. From 1985 to 1992, he served as a member of the U.S. Justice Department's National Environmental Enforcement Council. It worked to improve the environmental laws and their administration and the coordination by state and federal officials with respect to same. From 1986 to 1992, he served on the U.S. Justice Department's Executive Working Group for Federal, State and Local Prosecutorial Relations and in 1989 served as its Chairman. The Committee worked to improve our country's criminal laws and their administration and the coordination by the federal, state and local officials with respect to same. In the field of community service, Mr. Guste served as National President of the United Cancer

Council, Chairman of the Board of the National Housing Conference, Inc., President of Associated Catholic Charities of Greater New Orleans, President of the Metropolitan Crime Commission and President of the Council of Civic Club Presidents and as a member of the Juvenile Court Advisory Committee and as a member of the Board of Administrators of Charity Hospital in New Orleans. Mr. Guste wrote the first charter for Xavier University with Norman Francis, the first President of Xavier University—to name simply a few. With a long standing interest in public housing, Mr. Guste was one of the organizers and served as an advocacy member to the Board of Directors of UNITY for the Homeless, INC. a collaborative of organizations which works to provide housing for the homeless. Throughout his public career, Guste was the recipient of numerous awards for outstanding public service and leadership within the community. Highlights of these awards include: In 1974, he was awarded an Honorary Doctor of Laws from Loyola University for "concern for causes of the oppressed." In 1976, he received the Gautrelet Award of Springhill College, Mobile, Alabama, for his contribution in the field of public service and his leadership on behalf of his religious heritage. In 1980, he received the Pelican Award, the highest award given by the Ecology Center of Louisiana for work in protecting the environment. In 1989, he

received the award as the Louisiana Conservationist of the Year from the Louisiana Wildlife Federation, the National Wildlife Federation and Sears Roebuck for outstanding contributions for wise use and management of Louisiana's Natural Resources. In 1992, he was awarded an Honorary Degree of Doctor of Letters by Notre Dame Seminary of Louisiana. In 2000, Pope John Paul conferred upon him the Papal Honor of Knight Commander of the Order of St. Gregory the Great in recognition of "tireless efforts to serve God and neighbor". For his contribution to education, Mr. Guste was honored by having a local school named in his honor: Guste Elementary School. From the Anti-Defamation League, Mr. Guste received its highest honor, the A. I. Botnick Torch of Liberty Award. Mr. Guste was also a businessman with broad interest in the community. Mr. Guste and his brother, Roy Francis Guste, Sr. were fourth generation proprietors of Antoine's Restaurant in New Orleans. Mr. Guste is survived by his wife, the former Dorothy Schutten, and nine of their ten children, William J. Guste, III, Bernard R. Guste, Marie Louise Guste Nix, Sr. Melanie Ann Guste, RSCJ, Valerie Guste Johnson, Althea Guste Wise, Elizabeth Therese Guste, James Patrick Guste and Anne Duchesne Guste. Mr. and Mrs. Guste are the grandparents of 28 grandchildren and the great grandparents of 22. A Mass of Christian Burial was held on July 27th, 2013. Funeral services were private.



What It Takes To Be #1




New Council Development


MDF...A Blue Rose



In 2011-2012, 125 Councils participated in the Seminary Mission Fund Raffle and raised \$10,366 for each Seminary. Last year only 39 Councils participated, but those Councils raised \$10,500 for each Seminary. Our goal this year is to at least double the number of Councils participating and double the amount of money collected.
