## **DIRECTIONS TO ST. PHILIP NERI CHURCH HALL FOR COUNCIL 2893**

### **FROM THE NORTH (Oakdale, Oberlin, ETC)**

- TURN RIGHT ON FOURTH AVENUE (FIRST INTERSECTION AFTER THE OVERPASS; DRUG STORE ON THE CORNER)
- PROCEED FOUR BLOCKS; HALL IS ON THE CORNER ON THE RIGHT.

### **FROM THE SOUTH (US 165 FROM LAKE CHARLES, ETC.)**

- TRAVEL NORTH ON US 165 TO INTERSECTION OF THIRD AVENUE (US 190; **SECOND** TRAFFIC SIGNAL).
- TURN LEFT ON THIRD AVENUE AND PROCEED TO STOP SIGN.
- TURN RIGHT AT STOP SIGN AND PROCEED ONE BLOCK TO NEXT TRAFFIC SIGNAL (FOURTH AVENUE).
- TURN LEFT AND PROCEED TWO BLOCKS; HALL IS ON THE CORNER ON THE RIGHT.

### **FROM THE EAST (EUNICE, ETC.)**

- TRAVEL WEST ON US 190 TO INTERSECTION OF US 165 (FIRST TRAFFIC SIGNAL). PROCEED **THROUGH** THE TRAFFIC SIGNAL TO STOP SIGN.
- TURN RIGHT AT STOP SIGN AND PROCEED ONE BLOCK TO NEXT TRAFFIC SIGNAL (FOURTH AVENUE).
- TURN LEFT AND PROCEED TWO BLOCKS; HALL IS ON THE CORNER ON THE RIGHT.

### **FROM THE WEST (US 190 FROM RAGLEY, DEQUINCY, TEXAS, ETC.)**

- TRAVEL EAST ON US 190 TO INTERSECTION OF EIGHTH STREET. (FLASHING SIGNAL; RICE DRYER ON RIGHT)
- TURN RIGHT ON EIGHTH STREET.
- TURN RIGHT AT FIRST TRAFFIC SIGNAL ONTO FOURTH AVENUE AND PROCEED TWO BLOCKS. THE CHURCH HALL IS ON THE CORNER ON THE RIGHT.
