Re: Fourth Degree Exemplification

On Saturday, November 12, 2016, the District of Louisiana has scheduled a Fourth Degree Exemplification in Baton Rouge, LA. Bishop Ott Assembly # 2241 will host the exemplification. Sir Knight David W. Goldsmith is the host Faithful Navigator.

The Exemplification will be held at the St. John Vianney Catholic Church 16166 S. Harrell's Ferry Road, Baton Rouge, LA. Check-in will be from 7:30 a.m. to 9:45 a.m. The Exemplification cost for candidates is \$70.00, which includes their banquet meal, Baldric, and Fourth Degree Pin. Reservations for the Exemplification and banquet meal must be made with the Master, with the forms provided, no later than November 1, 2014. The Exemplification will begin promptly at 10:00 a.m. and will conclude at 12:00 Noon. The banquet will begin at 12:30 p.m. The cost of the banquet for **all**, Sir Knights, their spouses, candidate's spouses, and guests will be \$20.00 each. The banquet will be held at the **Church Cafeteria**.

All registration forms (see attached) and Form 4 (must be filled out completely) for candidates for this exemplification and must be received no later than November 1, 2016. The candidate must make his check payable to the assembly and the assembly submits one check for all candidates made payable to: Master's Fund. Forward only the Supreme Secretary's and the Master's copy of the Form 4 with the assembly checks to the Master. No personal checks made to the Master's Fund will be accepted.

As a reminder, the official dress code for all candidates and Sir Knights for all Fourth Degree Exemplifications is black tuxedo, **plain white pleated tuxedo shirt with lay down collar**, black bow tie, black cummerbund, black socks, and black shoes. Sir Knights will wear their social baldric with their attire. The only exceptions are clergy, deacons, and candidates presently enlisted in military service, who may wear their FULL dress uniform.

The ladies entertainment will be provided by Bishop Ott Assembly #2411 at no cost. Please let us know, no later than November 1, 2016 who will be attending.
