To qualify for the award:

1. Conduct 16 major programs. (At least four (4) programs in each of the four categories: Community, Faith, Family, and Life.)

2. Conduct the 4 mandatory programs:

Faith: [Spiritual Reflection Program](#)
Family: [Consecration to the Holy Family Program](#)
Community: [Helping Hands Program](#)
Life: [Novena for Life Program](#)

3. Submit the Annual Survey of Fraternal Activity (#1728).

4. Submit the Service Program Personnel Report (#365).

5. Comply with all Safe Environment Program requirements.

NOTES: Councils are permitted to report programs that are not part of the recommended Faith in Action programs as long as the program is a major program and reported in the proper category.

If your council conducts a featured program, ensure that the program's minimum requirements are met and is reported and submitted on the proper form in order to receive credit for two activities in that category.
