

May we all remain: One in the Lord





Well, KCLS is finally here and we're excited about the agenda we have planned for our Council Culture of Life Chair Couples. That brings us to our latest news. Pro-Life, one of our newest program areas, now has a new name: "Culture of Life". "Culture of Life" is a term that has been used extensively by our Church & by the Supreme Council for many years and was actually included in the original notes on our State Pro-Life Activity Report when it was composed three or four years ago.

"Culture of Life" covers important areas of focus that "Pro-Life" may not appear to encompass. Although some of us have included such issues as our fight for religious freedom, the healthcare mandate, and <u>all</u> of the seven "non-negotiable" or "life issues" often hi-lighted by our Catholic Bishops, some of these issues were apparently never completely thought of by most people as "Pro-Life"; hence, the reason for the change.

The term "Culture of Life" brings "to the table" all of the life issues: abortion, fetal stem cell research, euthanasia, human cloning, homosexual marriage, end of life issues, assisted suicide, and anything else that affects or undermines our culture of life. The important thing to remember is that as Culture of Life Chair Couples, we will continue to sponsor & participate in the same programs & activities, focus on the same topics, and use the same materials & forms that we used before. The only real difference is that some things we labeled "Pro-Life" will now be "Culture of Life", and certain programs & activities we may not have "officially" overseen before, will now fall under our program area. In some instances, we will continue to use the term "Pro-Life".

Now back to KCLS, where we have our one & only opportunity each year to meet & help educate our Council Pro-Life Chair Couples. This year's seminar will be, we hope, a more "fun" program for everyone who participates. Yes, participates. This year we will have a lot less "lecturing" and a lot more time for our Council Pro-Life Chair Couples to talk themselves. Chair Couples will be encouraged to share their experiences in the many programs & activities they did throughout the year. 
It is that time of year for the Mental Disability Fund Drive. When Knights of Columbus helps citizens to learn to help them selves by having a fund drive.



Louisiana Camp Joshua is a weekend camp designed to train high school sophomores, juniors, and seniors to be pro-life leaders. The weekend is designed to instill in them the strength, knowledge, wisdom, tools and courage to go out and proclaim the message of life to their schools and in their future. This event is sponsored by the Knights of Columbus, Louisiana Right to Life, and Louisiana Students for Life.

On February 24-26, 2012 we hosted our second "Louisiana Camp Joshua" at the beautiful ground of "The Gospel Center Inc" in Ruston. There were 34 students in attendance which was very good. Speakers Deb Brittain of Ark-LA-Tex Crisis Pregnancy Center and Ben Clapper of Louisiana Right to Life shared their knowledge on life issues and pro-life apologetics. Then Friday night we roasted smores around a camp fire and played Capture the Flag. Lisa Gould, a post-abortive prolife activist, gave a powerful testimony of her experiences with abortion and what she is now doing to defend the unborn. Speakers David and Lauren Merrick shared with students the connection between being pro-life and living a life of chastity. Students also had the honor of a visit from Rep. Frank Hoffman who shared on pro-life leadership and legislation. Then the students went canoeing on the lake and had a great time. We wrapped the weekend up with how to take this weekend and go forth and one of the best closing ceremonies we have had that really inspired the students. I find out a week ago that from that Camp we look to be having 3 Pro Life groups started in the Shreveport / Ruston Area.

There were 2 Baton Rouge Camp Joshua's held at the Bishop Tracy Center in Baton Rouge this year. The first one was on the weekend of March 16-18, 2012 with 57 students in attendance. The second one was held on April 13-15, 2012 with 62 students in attendance. This gives us a total of 119 students attending Camp Joshua in Baton Rouge this year. We are truly blessed to have so many young leaders thriving for knowledge to help fight the pro life cause. There will definitely be some GREAT results from these young Joshua attendees. The conference room was set with tables and chairs conducive for listening and taking notes. They would listen to the presentations and then break out into small groups for discussions with trained group leaders from the various colleges Right to Life groups.

The weekend was jammed packed with speakers starting Friday night with Pro-Life Jeopardy and Ben Clapper from "Louisiana Right to Life" gave presentations on "Abortion 101". Then Saturday morning picked back up with "Abortion 201 and pro-Life Persuasion. The Pro-Life, Pro-Chastity" was given by Jason Angelette. That afternoon they left for a field trip to the Governors Mansion and State Capitol where Senator Broome spoke to the students and answered questions. They then took a tour and had dinner at the Mansion. Dinner was supplied by Council 6389 from St Amant with the help of members from their Squires Circle.

When they got back form the Governors Mansion Saturday night they had our traditional Coffeehouse party in the cafeteria where they played music, sang songs, danced and had a good time together. Sunday morning they learned ideas of things they can do on their campus to make a difference. Later that morning the "Louisiana Students for Life" presented on "Transforming Character into Action" where they learned what to do now that the weekend is over. This was a very intense question and answer session which dealt with specific issues confronting students at their schools and community. They covered issues such as starting up Pro Life groups, doing Pro Life activism in their schools and communities, and many more ideas. Then we closed with lunch and a "Commissioning Ceremony" was held where they were told with scripture to go forth and "Be Joshua to the World".

Brother Knights, we have had 153 quality young students attend Camp Joshua this year and gain the Knowledge to go into this world and help with the Pro Life Movement. With everything going on this country today with our religious Freedom and Culture of Life issues we need more than ever to continue to train these young leaders to take a stand. Each year, the Knights of Columbus provide funding for the annual Mission trips at Notre Dame Seminary in New Orleans and St. Joseph Seminary College in Covington. This year, we will begin a new program replacing the current Acompano Raffle Program.

A Brief Background

Notre Dame's Acompano mission program was started in 1988 by then Rector, Msgr. Gregory Aymond. In 1995, the program was moved from Mexico to Nicaragua. It continues there today. Acompano inserts the seminarians into the Central American culture and allows them to see the missionary work of the Church first hand.

St. Joseph Seminary College began sending seminarians on a mission trip to Guatemala in 2003. Fr. Gregory Boquet, President-Rector, asked the director of the New Orleans Maryknoll Mission Education and Promotion Office to take some of his students on a mission trip. Fr. Gregory decided to make the mission program mandatory for seniors.

Both programs are seen as important to the seminarians' development as future priests. The mission trips are more about being with than doing for. Seminarians observe and learn as much as they work and assist. The trips help to expand the pastoral vision of the seminarians. The New Program

The new program will be a fund raiser similar to the MDF and YEP programs. We suggest you ask your Pastor to hold a second collection to benefit the Mission trips. Sample envelopes that can be used will be available at KCLS. Councils should order envelopes for their own Parish. We would like to institute the program when the seminarians are on a semester break. Summer, Thanksgiving or Christmas would be a very good time. If a seminarian is assigned to your Parish, ask the seminarian to introduce the program from the pulpit in order to raise public awareness and the funds necessary for the success of the program. If a seminarian is not assigned to your Parish, perhaps a Priest or Deacon could speak. If not, a script will be available for the Grand Knight or other member of the Council to speak.

We would like to receive one check, either from the Parish Church or your Council for the funds collected. The top ten Councils raising the most funds will be acknowledged, with a special award for the top Council. This award will be presented at the Convention Banquet.

We hope that this new program will allow the Knights of Columbus to increase the funding currently provided to the two Seminaries. This will help ensure that our seminarians will benefit from these mission trips.

Each one of us needs to look after the good of the people around us, asking ourselves, "how can I help?"



# **Coats for Kids**

With many families with young children continuing to struggle in these challenging economic times, there has never been a better time for Knights of Columbus Councils to help by providing warm coats to children in their communities through the Order's "Coats for Kids" program.

For the 2011-2012 winter season, 698 Knights of Columbus Councils purchased and distributed 26,028 coats. In addition, the Supreme Council also purchased 5,500 coats that were sent to several State Councils for distribution, for a total of 31,528 coats given out. This is a significant increase over the 2010-2011 number of 17,626 coats distributed.

Since 2009, the Knights of Columbus has distributed more than 70,000 coats to kids throughout the United States and Canada.

All Knights of Columbus Councils are invited and urged to participate in the "Coats for Kids" this coming Winter. Simply complete and submit the "Coats for Kids" order form, and you'll get your coats in about two to three weeks. The minimum order is one case of 12 coats, and the cost is \$195.00 per case (\$16.25 per coat). Shipping charges are added to each order, but the Supreme Council will pick up half of the shipping costs on every order placed by a Knights of Columbus Council. Each case of highquality coats will contain either boys or girls coats, both of which come in a variety of sizes (4-16 for girls, 4-18 for boys), styles and colors.

It's getting hot outside and that is a sign that the new Columbian Year has just started to heat up. Welcome to this year's CYLA program. I am looking forward to this being the best year ever of the program and to assist each council in selecting their winners to be recognized locally and competing at the Area level.

The Catholic Youth Leadership Award Program is one of the most dynamic and rewarding programs that the State Council offers to the Membership. CYLA places an emphasis on Catholic values, scholastic achievement, athlet-

ics, and leadership in the areas of church, school and community. Catholic seniors throughout the state of Louisiana are eligible to participate in the CYLA program. The only requirement is that they must be nominated by a council within the Louisiana jurisdiction. Each council that participates in the CYLA program will find it to be both rewarding and fulfilling. Giving outstanding Catholic seniors the opportunity to compete for cash prizes, awards, and recognition is the very foundation of the CYLA program.

CYLA packets will be mailed out to the Grand Knight in early November. Appeals are made on behalf of CYLA at the state officers' meeting and at Grand Knights' day, encouraging councils to participate in the program. Councils that participate in the program turn in their nomination forms to the Area Coordinators. Area Coordinators conduct their respective area competition and award one boy and one girl the distinction of being an area winner as well as a state finalist. The Area Coordinator then sends the nomination forms of the finalist to the state chairman. A total of 22 finalists will compete for the state championship. Then the copies of the nomination forms are mailed to the state judges for grading. Upon completion by the state judges, the scores are tallied by the state chairman and are used as part of the overall score of the finalist. The appointed ten state level judges will conduct the verbal competition on April 7th in Lafayette.

Every student nominee should utilize the online interactive nomination form found at the state web site. This allows for a neater and more standardized application to be produced, permitting the maximum room for content to describe the nominee's activities and accomplishments.

# Good of the Order

### To: The Officers and Members of the 107th Annual Meeting of the Louisiana State Council held in Kenner, La.

Your committee on the Good of the Order met on Saturday, May 5, 2012, and fully discussed at length the following activity areas. After due deliberation, the committee urges all council, district and state leaders to see that the following recommendations are fully implemented.

The committee would also ask that at future conventions, each member of the Good of the Order Committee, as appointed, be forwarded a copy of the previous year's Good of the Order report to prepare committee members as to what is to be discussed.

FIRST AND FOREMOST WEARE CATHOLIC. The committee recommends the recitation of the Serran Prayer for Vocations, or another appropriate vocations prayer, at each council meeting and that the council chaplain should encourage the recitation of this prayer at all Masses. The committee further recommends that a prayer be offered at each council meeting for the beatification of our founder Father Michael J. McGivney. The council chaplain should be encouraged to be actively involved in council activities. In the absence of the council Chaplain, a deacon shall be asked to bring the message of our faith. The committee urges all councils to participate in the Refund Support Vocations Program (RSVP). Each council should consider sponsoring a speaker on vocations to

the various parochial schools. Recognizing that some clergy may still be apprehensive to Knights of Columbus involvement, the committee recommends each council strongly consider implementation of the Parish Round Table Program and thus show evidence of our belief that VOCATIONS ARE OUR BUSINESS and that each Grand Knight has a dialogue with each Pastor of churches in his council area. Each council should consider having a speaker on evangelization, to encourage each member to promote the Catholic faith to non-Catholics, and to help fallen-away Catholics to become again active in the Church. One way this can be done effectively is by supporting evangelization through the RCIA program.

PRO-LIFE. The committee recommends increased efforts from the state level to provide more timely and specific information to the council level about upcoming activities such as Pro-Life Rallies. The committee encourages area, district and local Right to Life Masses and demonstrations. It is also recommended that continued active exposure to the public by each council be pursued. The committee encourages each council to construct a monument to the unborn in a prominent place, preferably on the church grounds and those that have one to maintain and have programs to bring Pro-Life to parishioners attention. We urge right-to-life education, to fight abortion, and specific projects, such as enforcement by members and Grand Knights of letter writing campaigns from council members to state and federal governing bodies. We also urge the use of the vast amount of material that is available about the AIDS Virus, and promoting abstinence and chastity as a way of decreasing the threat of AIDS as well as decreasing abortions and moral decay.

The committee also recommends that councils become involved with local Right-To-Life organizations by way of participating in their events and getting on their mailing lists. The committee urges use of material available to them from the Supreme Council pertaining to Pro-Life. The committee also urges members to fight pornography at the council, family and school levels. The committee further recommends that the State Council provide updated information of current Federal and State legislation on Pro-Life and Euthanasia.

The Committee reommends each council appoints a Pro-Life Chairman or Chair-Couple; supports a youth Pro-Life Retreat as sponsored by the State Council; and offer a Pro-Life prayer at business meetings.

**BISHOP GRECO MEMO-RIAL FUND**. The committee recommends that all councils use the memorial cards to memorialize deceased council members. The card can be filled in with the name of the deceased and the name of the donating council. Thecard is mailed to the member's family. A suggested donation of \$25.00, however any amount is accpeted, and sent to the Greco Foundation for the

In 1913, Knights of Columbus AWARD Council No. 1337 was chartered to operate Boy Scout Troop 1 in Monroe, Louisiana. In 1923, the Supreme Council formally commended Scouting as "a fruitful activity for the Order" and said that local councils had "molded young boys" through the Scouting program. For more than 90 years, the Knights have worked with the Boy Scouts of America to serve youth. The Knights continue to shape lives by serving more than 42,000 young people in more than 1,400 Scouting units. As of 2005, the K of C had more than 150 Scouting units that had 50 or more years' tenure and more than 800 KC councils were ensuring that young people receive a Scouting opportunity.

In 2006, the Knights of Columbus and the National Catholic Committee on Scouting teamed up to start new Scouting units. The Louisiana State Council has taken that partnership and expanded it to create a dynamic program to help bring the Knights and Scouting closer together.

The Scouting Program of the Louisiana State Council consists of five items:

1. Retention of Cub Scout, Boy Scout and Venturing units that are in danger of folding due to the loss of their chartering partner;

2. The creation of new Cub Scout, can make arrangements to have the Boy Scout and Venturing units to bring award presented. The complete list of

the Scouting program to underserved areas;

 The promotion and sponsorship of the Catholic Religious Emblems program;

4. The promotion of increased volunteerism in the Scouting program by our Brother Knights, at the unit, district and/or diocesan levels;

5. Recognition of Brother Knights who have given years of service to the Boy Scouts of America though a new state award, the Francis J. Parater Award.

In keeping with the twelfth point of the Scout Law, A SCOUT IS REV-ERENT, the Louisiana State Council of the Knights of Columbus wishes to recognize those active adult Knights who have contributed significantly to the spiritual growth and development of the youth of their communities by volunteering their time, talents and resources to the local units of the Boy Scouts of America. The spirit and intent of this recognition is in keeping with the philosophies and purposes of the Knights of Columbus and the Boy Scouts of America.

The Knights of Columbus is a strong supporter of the scouting program, having sponsored hundreds on troops, packs and crews throughout these United States. This award is named after Francis J. Parater, Eagle Scout, Knights of Columbus associate and seminarian, who worked extensively with youth during his short life. The Knights wish to recognize brother Knights who have helped our youth along their journey in life.

While we had a number of bumps in the road to get this program up and running, the awards are now made and I will be contacting each of the councils that nominated a Brother Knight so we can make arrangements to have the award presented. 

trust fund.

The committee also recommends that councils make a voluntary contribution of \$1.00 per member, on annual basis, to the Bishop Greco Memorial Fund..

**RETREATS**. The committee recommends that each council have a guest speaker with Catholic Retreats as the subject, and schedule retreats for its members, individual as well as couples, encouraging husband and wife retreats whenever offered.

FAMILY INVOLVEMENT. The committee recommends continual family involvement in council activities. The committee also recommends each council have a monthly Family Communion. The committee strongly recommends that widows of deceased council members be included and recognized in every aspect of the council's life and activity. This committee further recommends that the council members make themselves available to provide assistance to widows and receive a copy of the council news letter and provide transportation if needed.

YOUTH EXPANSION PRO-GRAM. The committee urges each council to actively support the Youth Expansion Program by annually exceeding it's YEP quota, and by involvement in a youth organization such as Columbian Squires, Boy or Girl Scouts and/or Catholic Youth Organization (CYO). The committee recommends that all members in each council be asked to make a personal contribution to our Youth Expansion Program and councils should not depend on fundraisers only. Each council should consider either making it a part of the dues or adding to their billing a \$10.00 voluntary contribution by each member. The committee recommends that all councils participate in the CYLA Program and that efforts be made to properly recognize the applicants and winners on the council level.

SUBSTANCE ABUSE-HEALTH SERVICES. The committee recommends each council sponsor an educational program on substance abuse by the law enforcement agencies to local junior and senior high schools. The committee urges all Knights to recognize local, state and federal law enforcement agencies. The committee further recommends that councils establish blood donation drives, Cardiopulmonary Resuscitation (CPR) training programs and community blood pressure surveys.

**FRATERNAL MEMBER-**SHIP-NEW COUNCIL DEVEL-**OPMENT**. The committee wishes to compliment the first degree and major degree teams in the Louisiana Jurisdiction for their excellent exemplifications which act as catalysts in encouraging all councils to obtain new, active members. The committee wishes to remind all members that it is our Supreme Council's desire that we have a KC presence in every church parish and that we should aid all efforts to form a new council or a Parish Round Table. It is also recommended that all members proposing new members into our Or-

der assume responsibility for insuring the first-degree member receives his major degree as soon as possible, and remains an active member. Also, we congratulate all councils that sponsor a first degree teams and we strongly recommend that every council make an attempt to establish a team, and that all ceremonials be performed with the proper dignity. The committee recommends that every council make an effort to bring in new members, but that no less effort be expended to retain the members they now have. Council leaders and members should promote patriotism and encourage members of the third degree to join the fourth degree. Councils should make an effort to form and support a Columbian Squires Circle which can be a future source of membership and Ladies Auxiliary. The committee recommends the promoting of young members and make officers and active members promote young ideas. "Turn over the power". Make the KC's a place for young and old to blend and provide babysitters whenever possible. The committee also recommends that all councils send out bulletins monthly or quarterly, and that copies of the bulletin or newsletter be sent to five councils in the state, on a random basis, for the purpose of spreading and stimulating new ideas.

**INSURANCE**. In view of our Founder Father Michael J. McGivney's purpose to form a Fraternal Benefit Society so that the widows and chil-

dren of members in the group when the member dies would not find themselves in dire financial straights, Knights of Columbus Insurance was instituted. As the insurance program not only provides this coverage but also helps to finance many of the programs of the Knights of Columbus, we encourage all members to become insurance members, especially State and Council leaders. The committee recommends that all councils have adequate liability insurance as recommended by Supreme.

**PROTOCOL**. The committee recommends that members of the clergy and Knights of Columbus State Family and officers be properly recognized as to their titles or positions at all Knights of Columbus meetings and functions. Also, we remind members of all the important aspects of protocol as explained in the protocol booklet. The committee also recommends that the State Officers reinstate the policy of visiting subordinate councils and protocol be strictly adhered to.

**SERVICE MENTALLY HANDICAPPED CITIZENS**. The Louisiana Knights of Columbus are to be complimented for the tremendous support of the annual statewide fund raising program benefiting the learning impaired. Each council is called upon to continue this important work and to utilize to the fullest the involvement of families, Boy Scouts, Columbian Squires and Ladies Auxiliaries in the fund raising campaign. The committee recommends that councils use publicity to promote the Knight of Columbus donations by secular and religious newspapers. It is recommended that councils become more involved with activities of the learning impaired citizens at the local level and present the funds to them in a personal manner. The committee also urges councils to actively support the Special Olympics Program, as well as St. Mary's Training Facility in Alexandria.

SUPPORT OF THE ELD-ERLYAND INFIRMED. The committee urges each council to become actively involved in providing support for the elderly and infirmed citizens of our communities through such activities as weekly or monthly bingos at the retirement or health care facility, also Christmas-Thanksgiving Dinners, sponsoring Masses and communion services at the facility or just plain visitations. The committee also recommends that councils try to promote these programs at all times of the year, not only holidays and special occasions.

**CONCLUSION**. The committee urges all councils to implement to the fullest extent, the foregoing recommendations. In order to obtain the fullest implementation of these recommendations, the <u>committee urges the State</u> <u>Deputy to insure that all councils receive and display</u> a copy of this report, and that a summary of this report be published in the June issue of the <u>LOUISIANA KNIGHT</u>. As a chairman of the Good of the Order committee, I would like to thank all committee members for their attendance, input, and participation at our meeting Saturday morning. I would also like to thank the State Deputy for the privilege of serving on this committee.

ishes that do not know the Knights of Columbus or could benefit from a Council devoted to that specific Church parish. You have all done unimaginable things with the Order, things that even I could not have imagined; yet, the most basic has remained unfulfilled. And that is to establish a Council in evey Church parish. I will continue to pray for and encourage that endeavor."

Brothers in the State of Louisiana, there are 80 Church parishes with 100 or more registered families, without a Knights of Columbus Council or being served through the Round Table Program. 35 of these have over 500 registered families. Brothers, can we possibly add councils in these 80 Church parishes? How about those Church parishes with 500 or more registered families? Fr. McGivney said yes, we can.

Another Statistic : There are 88 Councils that are serving two or more

Church parishes through the RoundTable program in the State. Could we form another Council in one of the multiple Church parishes served by these 88 Councils? Would this give the opportunity for increasing membership in the state? Could this give additional brothers the opportunity to serve as new Council officers; to better serve the Church parish? Again, Fr. McGivney said, yes we can.

Brothers, I will soon send out information to District Deputies concerning the possibility of forming new Councils in 37 Church parishes in their districts. I ask the District Deputies, or anyone interested in the potential for forming a new Council in any parish in the state, to contact me and I will get the information to them about the potential new Council Church parishes in their area.

Brothers, a Council in every Church parish is definitely possible, if we think positive like Fr. Michael J. McGivney did in 1982.

One full size Flag that was brought to be retired, but, was Not Retired when we realized it only had 48 Stars and that it was 71 years old and in mint condition. Speaking to the person that brought it in, I was told he did not have anyone to leave to when he was gone. It was his father's Burial Flag from Dec 11<sup>th</sup>, 1941. He has given me the flag after I told him that we would like to use it for Education purposes and for Special Patriotic Events. I am having a special display case built for it along with the history of it.

The flag was professionally cleaned and yesterday, July 4<sup>th</sup>, that flag was flown for the 1<sup>st</sup> time in 71 years at a 4<sup>th</sup> of July Parade and Celebration in New Iberia.
